After the business meeting, Bill Niemuth provided an overview of the COVID-19 situation and shared several informational resources. The FVC used Chatham House Rules to ensure we could share information but protect the identities of individuals and their organizations.

Overall, members and their organizations have started to move away from the concentrating on the numbers and are focusing on doing stuff, which has helped reduce crisis fatigue. Members and their organizations are also developing business recovery plans, while not placing any hard timelines on the recovery. Consensus is the recovery will be a stepped approach.

Here are some great key knowledge points:

- Getting PPE to frontline employees is a priority.
- Employees who cross state lines to work is a challenge in some places because of home rule and varied enforcement actions.
- Visitor and employee screening is being done, but the use of infrared thermometers in cold environments is not effective.
- Some businesses are hit very hard, some not so much, and for some business is very strong.
- Effective and frequent internal communications are critical for success, especially with line employees.
- Business recovery planning is ramping up.
- It is a great time to be innovative with team building. Try virtual lunches, incentive activities, and giveaways. Reducing stress is really important these days.
- Virtual/remote working will be the norm as we evolve out of COVID-19.

COVID-19 Business Recovery Planning

All crises and disasters have a certain shelf life. Human psychology forces us to move onto the next step sometimes even before the situation is ready for it. Perhaps that is why we keep moving forward?

It was wonderful to hear our members talk about this transition in real time. I have witnessed crisis fatigue many times throughout my career and have made the mistake more than once in staying in crisis mode too long. Operationally, perhaps it made sense, but emotionally, it was time to move on.

As organizations move beyond the crisis, what does business recovery planning look like? That depends upon your organization, but the planning process should be consistent. Planning should be simple, specific, and realistic. Depending upon your customers, service, or product bringing your business back-up will likely not be done all at once. Not many organizations can start from 0 and go to 100% or even 60% immediately. What to bring up requires open and honest feedback and prioritization. It can be a stark reality and challenging for us to deal with. Senior leaders need to make strong decisions and be committed.

Perhaps the most challenging aspect of business recovery is the uncertainty of the timing, but that can be mitigated through a disciplined process that remains flexible and agile. Confidence, resolve, and a structured process help overcome crisis fatigue and keep us moving forward.
